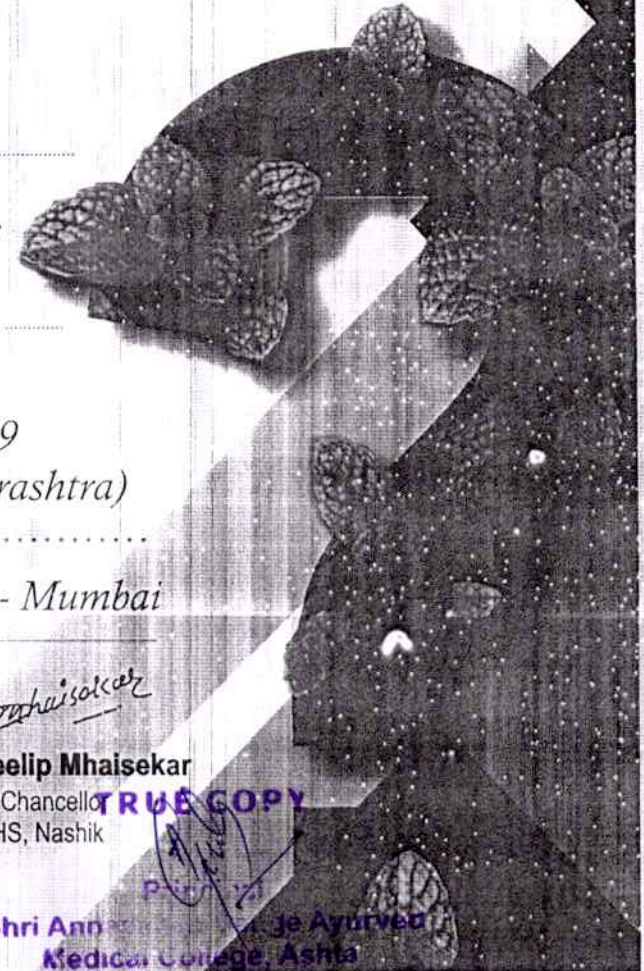

In case, if the category of candidate falls under any other category in the State Category List, candidates may apply to designated Counseling Authorities with their category as per State Category List, and Designated Counseling Authorities will verify the same. The same is the case with domicile. Domicile will be governed by respective admitting authority rules. NTA will not change any details of the candidates after declaration of result.
