A VC meeting was convened on 07.02.2023 at 2.30 pm in the committee room of CCRAS under the chairmanship of Prof. Vd. Rabinarayan Acharya, Director General, CCRAS with the identified twelve Ayurveda institutions/colleges in order to discuss initiation of different clinical study focussing Iron Deficiency Anemia (IDA) under the ambit of SMART program. At the outset, Prof. Vd. Rabinarayan Acharya, Director General, CCRAS welcomed and expressed gratitude to all the members from the identified Ayurveda institutions/ Colleges for responding to EOI. Further, Dr. Narayanam Srikanth, Deputy Director General, CCRAS, briefed about the need and objectives of SMART program. Following this, a brief presentation was made from CCRAS side highlighting the Terms of References (ToRs) and the outline of Iron deficiency Anemia (IDA) protocol.
